Cancellations are subject to a \$50 administrative fee in addition to all non-recoverable costs per the Wilmington Ski Club Cancellation and Refund Policy. Participant Liability Waiver, Release, Indemnity and Consent: Participant waives, releases and holds harmless the Wilmington Ski Club, its officers, directors, council members, activity leaders and club members, herein collectively referred to as the "Club", from and against any claims for personal injury, death, property damage, financial loss, delay or other loss incurred by Participant, herein "Loss", arising out of the Trip and all travel to and from the Trip destination, or due to any act or omission of any company or third party engaged in providing transportation, lodging or other services related to the Trip. Loss covered by this provision includes, without limitation, any Loss resulting from the inherent dangers and risks of skiing and/or snowboarding and any other activities occurring on the Trip. The waiver, release and indemnity contained in this provision exclude any Loss caused by gross negligence or willful misconduct of the Club. Participants are strongly encouraged to purchase trip insurance to protect themselves from any injury, damage, delay or loss that may occur related to the Trip. Participant's parent or guardian, if Participant is a minor, must accompany the Participant on the Trip and shall be responsible for the Participant's safety and behavior. Such Participant's parent or guardian undertakes the foregoing waiver, release and indemnity on behalf of the minor Participant.

This waiver, release and indemnity is binding on Participant and their heirs, personal representatives and assigns. **Participant acknowledges that he or she is a member of the Club, has read and understands the terms herein and has signed this voluntarily and freely.**

Participation Policy: Participation is governed by the WSC Policy. Trip participants are expected to be self-sufficient in all trip activities. At registration Participant is required to notify trip leaders in writing of any conditions that may require special diet or other needs. The Club and its tour operators are not required to provide any special services other than those listed on the trip brochure, description or flyer. The Wilmington Ski Club and its trip leaders reserve the right to remove any participant from a ski trip or other club activity who becomes a hazard to himself/herself or other members of the trip or activity, or for conduct endangering the good order, welfare, character or reputation of the Club.
